8. Composite Crews motion – Chloe Nicklin to speak

Remove A3.4a.2iii

'iii. shall only be permitted in Women's divisions'

Replace A3.4a.2iv

'iv. must be the lowest Women's boat for both constituent clubs'

with

'iv. must be the lowest boat for the given gender for both constituent clubs.

Proposed: Chloe Nicklin (St Hugh's)

Seconded: Jo Wharton (St Hugh's)

Intended to allow more athletes to race: current rules prevented some Hugh's rowers from participating in Eights, which is a shame.

POI: Previous motion was passed as an effort to bring parity between men's and women's participation – currently more men participate than women.

POI: Amendment added to force re-vote beginning every of HT, to see if motion is being successful.

POI: In reality no women's composites entered in Eights.

POI: Extraordinary sub rules normally allow 4th associate in bottom boat, if in Rowing On divisions. Composites currently only allowed in RO divisions.

POI: Tie in Torpids '18, potentially composites rules could allow 4 athletes from each crew to enter.

POI: Bumps is effectively college cuppers.

Vote: 10 in favour, 31 against, 19 abstentions. Motion fails

9. Proposed addition of Parks College to Pembroke College Boat Club – Benjie Stimpson to

speak

Add Rules of Racing A1.1.b.i.9:

"Pembroke College Boat Club also represents Parks College"

Note Rules of Racing A1.1.d:

"Any motion to amend the above rules must be brought in accordance with the procedural rules associated with a constitutional alteration under 1.11.5"

Constitution 1.11.5:

"Motions to alter the Constitution require a 2:1 majority of those in favour to those against, and an overall majority of those present and eligible to vote."

Proposed: Benjie Stimpson (Pembroke)

Seconded: Lena Depner (Pembroke)

Letter from Lionel Tarassenko (appendix) viewed. Intention for club to exist as merger for perhaps 10 years – eventually Parks to view

POI: Benet's has less than 100 potential rowers. Parks will very soon have more than that – can form its own club.

POI: Already a mechanism to allow members at a college without a boat club to row with a club of their choice (for example, Pembroke)

POI: The above does not bring certainty, which is desirable for those starting at Parks.

POI: Intention is to build from 50 to 200 per year, not 50/200 total. Up to 600 totals. Quite large.

Vote: 7 in favour, 33 against, 18 abstentions. Motion fails
